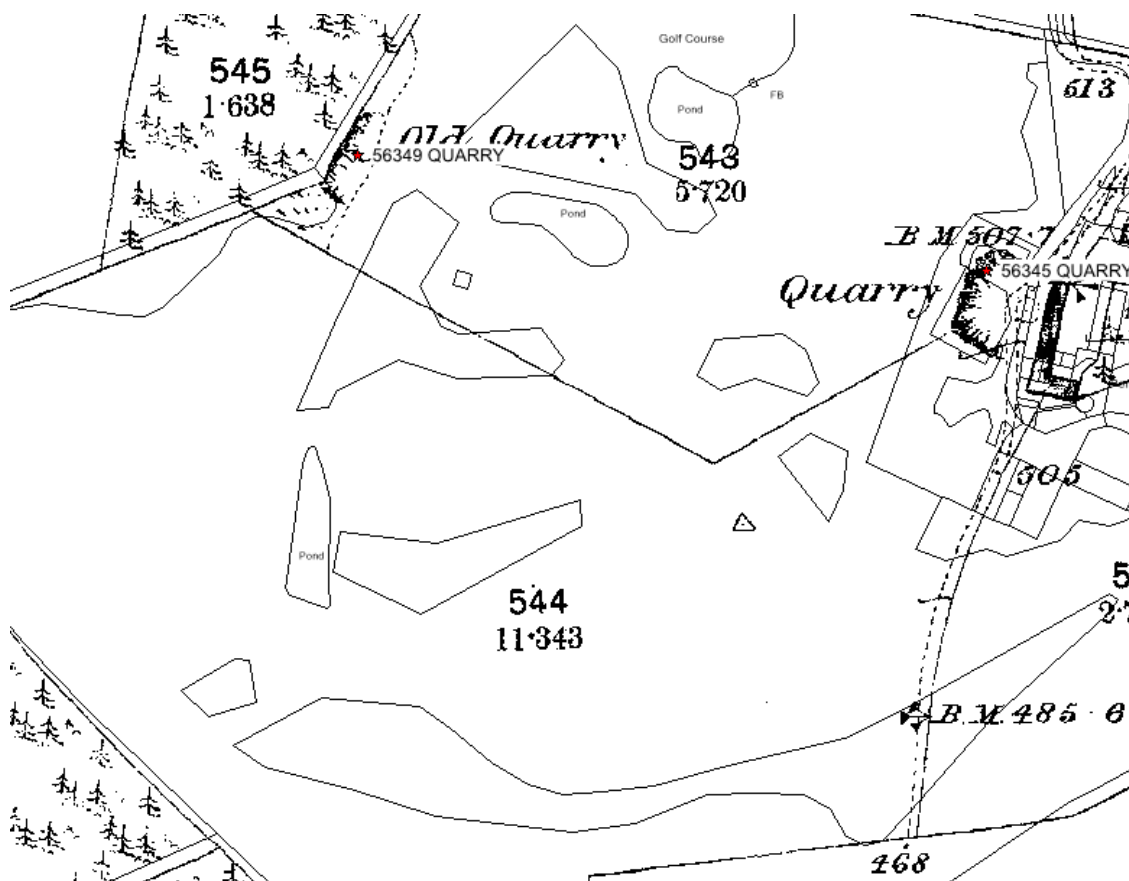



56345	A quarry marked on the 1st edition Ordnance Survey map of 1888 adjacent to Penlanlas.	Quarry	SN6067076757

Some of the consultation areas include, or are adjacent to historic Quarry sites, there is a strong potential for archaeological remains. The current condition of these features is unknown; however, they may survive as ruins, earthworks or below ground archaeology. Felling operations should avoid causing damage in these areas.

There is always the possibility for previously unknown remains to survive within this area of which we have no knowledge. Should further archaeological features or finds be identified it is important that Dyfed Archaeological Trust Heritage Management is informed and further information and advice can then be provided as required.
