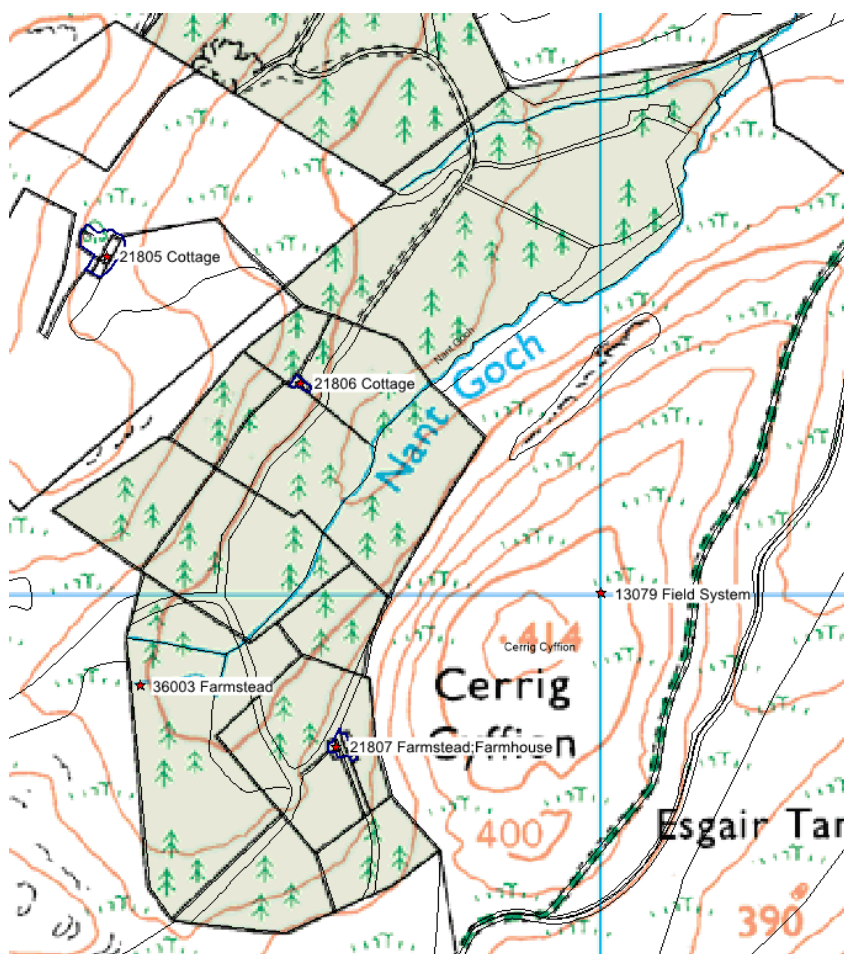

21807	Genealogical records of the use of the site in the mediaeval period. Later it became a farmhouse. F. Jones. An old farmstead in a forest compartment ride much damaged by fallen trees. Parts of the house are threatened by conifers planted around the structure. The farmhouse may be in the longhouse tradition; it measures circa 20m long with walls standing up to 2.5m maximum. One gable end stands to full original height (not measured). The building appears to be of drystone with evidence to show that it may have been limed. Some 8m to SW is a small square, drystone built, ancillary building with walls standing to a height of 1.5m. A roadway passes along the W side of the structure.
