



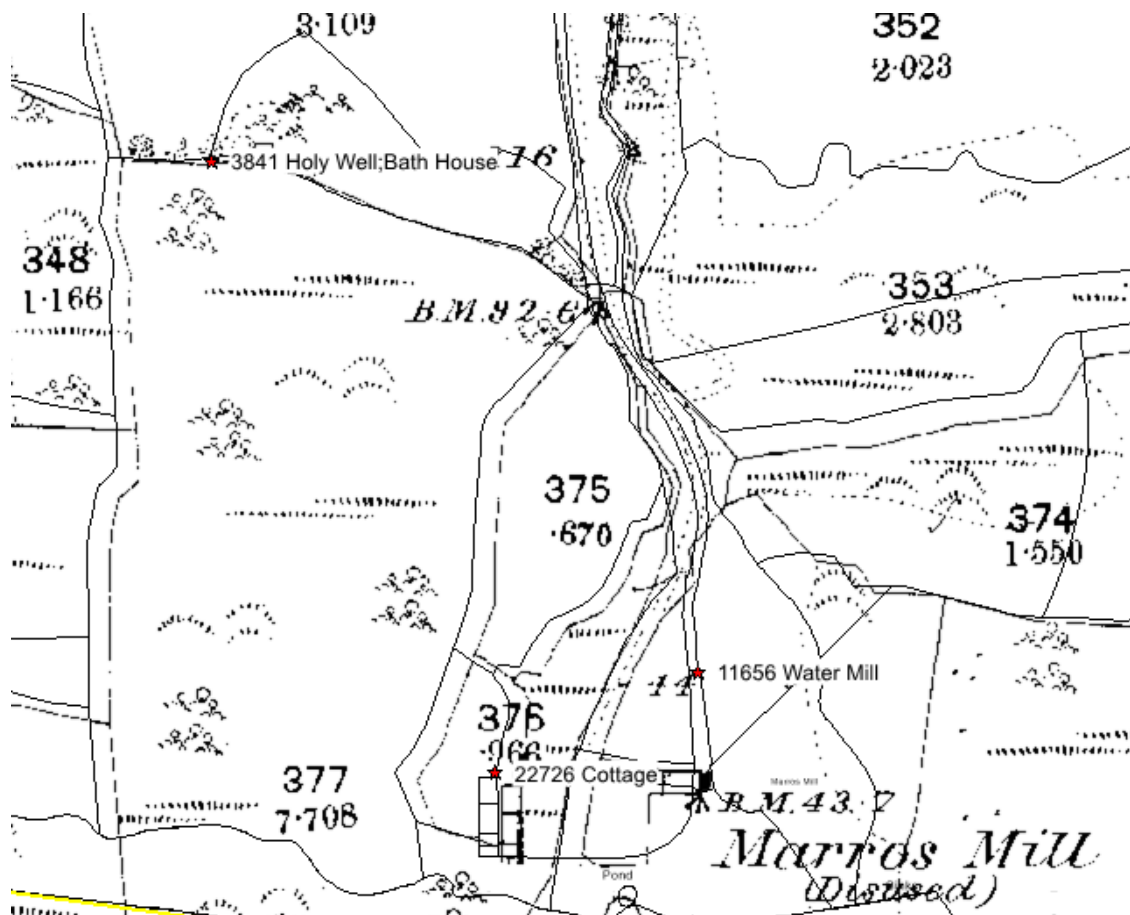



3841	Lady's Well, on Marros Mill Farm, is recorded in 1925-6 as comprising two rectangular, roofless chambers. In 1966 it is recorded as a wellhouse and leat (M.Ings, 2011, from various sources)	Holly Well: Bath House	SN20580770

The current condition of these features is unknown; however they may survive as ruins, earthworks or below ground archaeology. Felling operations should avoid causing damage in these areas.

There is always the possibility for previously unknown remains to survive within this area of which we have no knowledge. Should further archaeological features or finds be identified it is important that Dyfed Archaeological Trust Heritage Management is informed and further information and advice can then be provided as required.
