Thank you for your felling licence consultation. I have reviewed the map boundaries against the regional Historic Environment Record (HER) and other sources and note the following features (See attached map).

PRN 37770 POST MEDIEVAL COTTAGE SN68423318

This cottage appears on the tithe map (1839) but is absent from later map sources.

PRN 37768/9 POST MEDIEVAL COTTAGE SN68403321

Cottage seen on tithe map and named Cwm Marles on the 1891 Ordnance Survey maps. Earth bonded ruins survive at trackside.

PRN 128540 POST MEDIEVAL FOOTBRIDGE SN6846833090

Footbridge marked on 1st and 2nd edition 1:2500 Ordnance Survey Maps. E. Lloyd 2022.

PRN 128541 POST MEDIEVAL FORD SN6845233096

Ford marked on 1st and 2nd edition 1:2500 Ordnance Survey Maps. E. Lloyd 2022.

PRN 128542 POST MEDIEVAL SLUICE SN6845433111

Sluice marked on 2nd edition 1:2500 Ordnance Survey Maps. E. Lloyd 2022.

PRN 40393 POST MEDIEVAL Fulling Mill SN6845133122

The place name on early OS maps 'Felinban' indicates a fulling mill. There is now no trace of a building at this location.

PRN 128539 POST MEDIEVAL FORD SN6842732819

Ford marked on 2nd edition 1:2500 Ordnance Survey Maps. E. Lloyd 2022.

PRN 116582 POST MEDIEVAL FARMSTEAD SN6837732962

Farmstead recorded on 2nd edition, 1:2500 Ordnance Survey map.

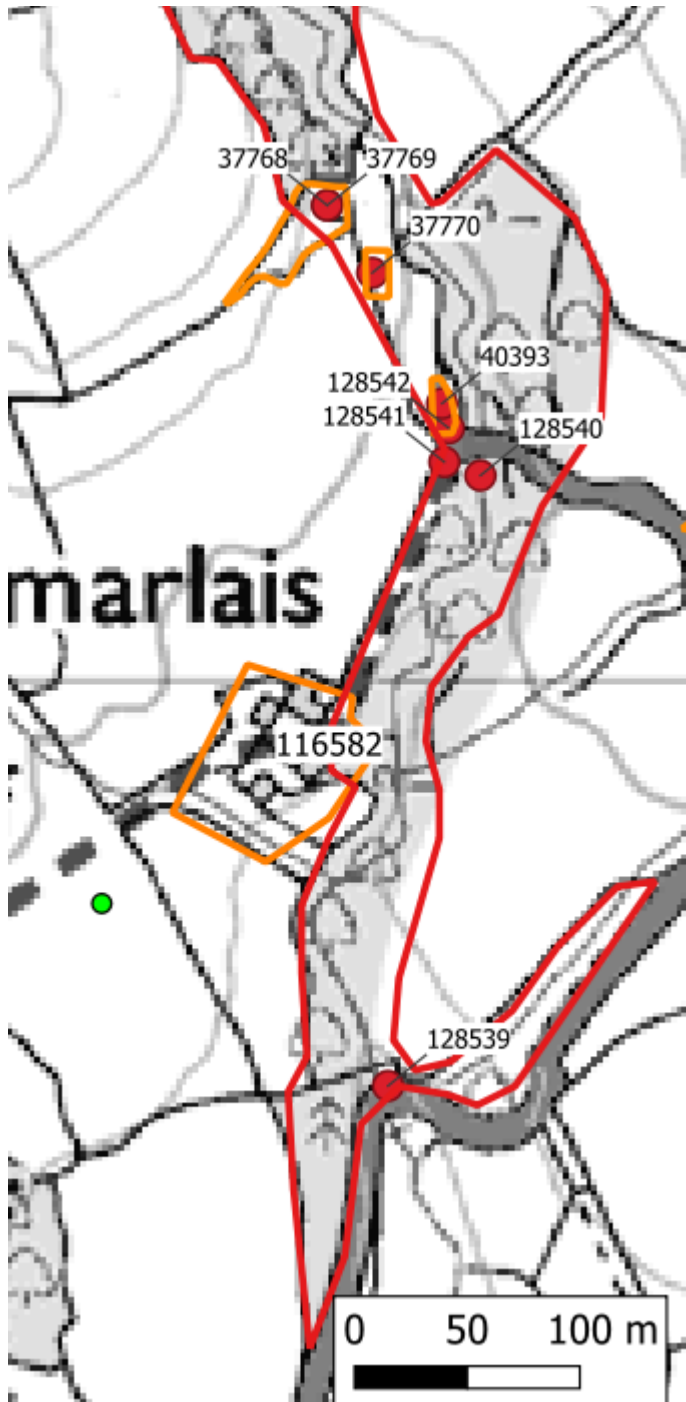
