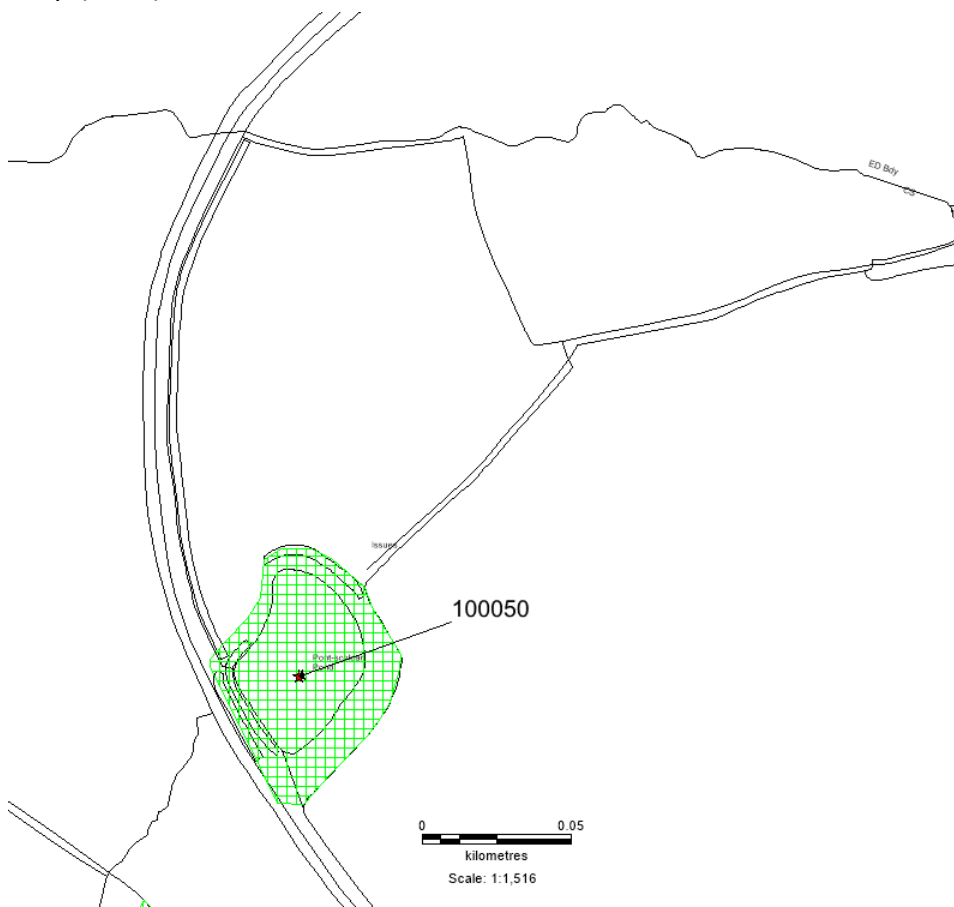

**NRW Screening Request
FLA307 23-24 Cilwendeg near Cardigan, Ceredigion**

Thank you for your felling licence consultation. I have reviewed the map boundaries against the regional Historic Environment Record (HER) and other sources and note that the felling takes place within the Registered Historic Park and Garden of Cilwendeg lodge (grade II listed lodge) PGW (Dy) 17(PEM), therefore Lisa Fiddes, Inspector for parks and gardens at Cadw (copied in) should be consulted.

I also note the following feature:
