Hi Paul,

I've checked your map against the Historic Environment Records we hold, along with other sources and note the following historic environment features, listed in the table and map below.

You'll note that a number of prehistoric burnt mounds have been recorded within the forest though efforts to find them in the 1990s have been unsuccessful. It's possible that they only survive now as below ground archaeological deposits.

Due to the potential for prehistoric archaeology, which has been previously recorded in this area, we'd recommend that an archaeological watching brief is carried out during any excavation which is necessary during the construction of this track. A suitably qualified archaeologist working to the standards and guidance of the Chartered Institute for Archaeologists is recommended to record any archaeological deposits uncovered during the topsoil removal and with the removal of the earthbank. 
