Hi Alice,

Hope you are well?

I am looking forward to the Spring. Rather fed up with being cold now.

Alice – my Integrated Engineering colleagues need to build a new forest road as shown on the attached plan. This road is required from a H&S perspective as it will allow hauliers to move timber without travelling past the Visitor Centre – a high rec area.

We have just noted (at rather a late stage in the process I am afraid – my fault I think) that there is a heritage feature crossing the proposed new road, being the course of a pipeline recorded on 1891 maps, part of the Aberystwyth Corporation Water Supply. There is no obvious physical evidence of a linear feature (I would suppose it would mostly be underground) but I note that there is an aqueduct conveying the pipeline over stream gulley further up the forest road.

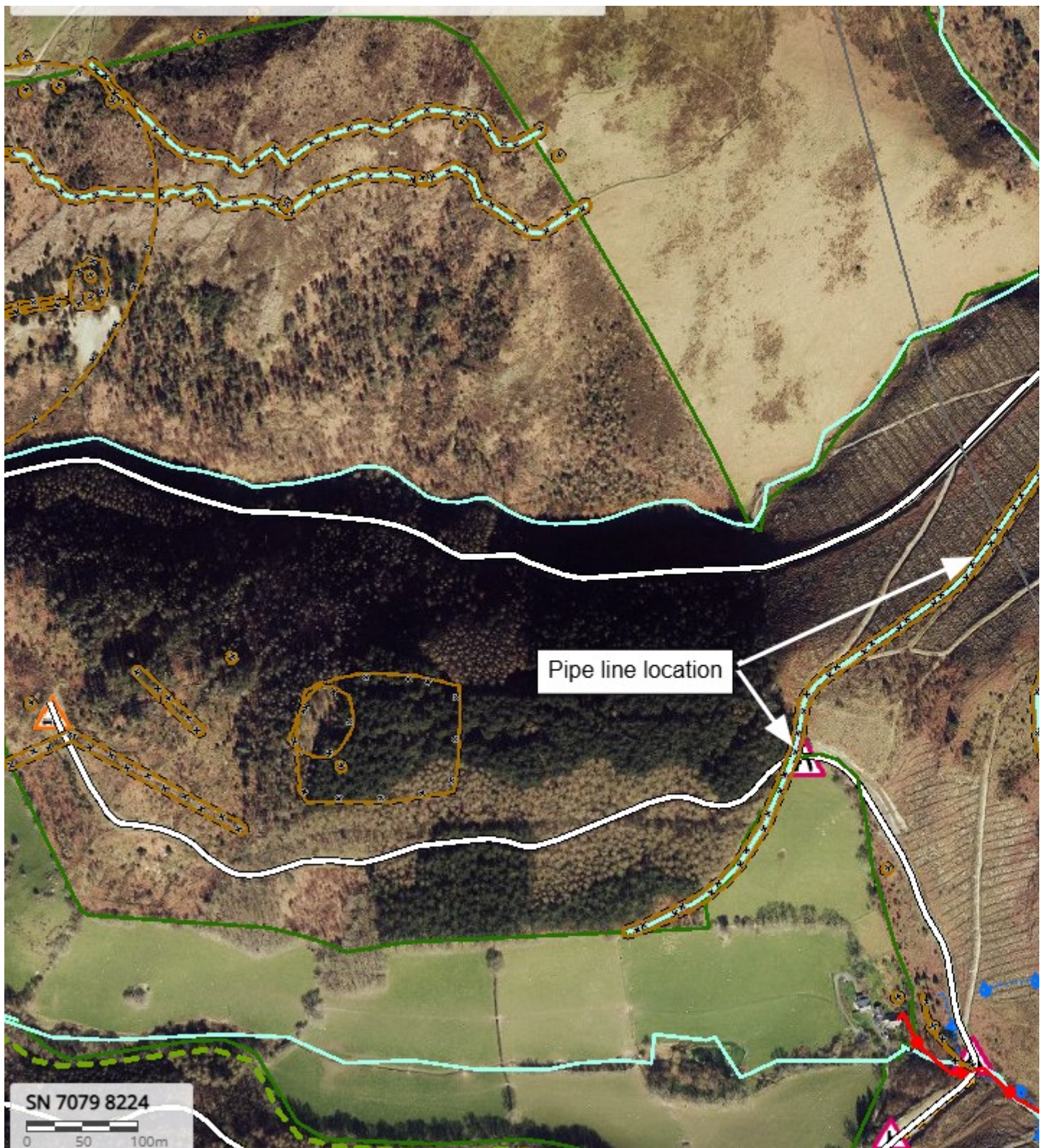
Please see the screengrab below, showing the location of the heritage feature.
