Morewoods MWA4022 Land Near Trelech

Dear Alison,

Thank you for consulting us on the proposed woodland creation scheme on land near Trelech.

Whilst reviewing the available historic resources, I noted the presence of a cottage in the northeast corner of the consultation area that was not yet recorded on the Historic Environment Record (HER). It is not clear whether this feature lies within the consultation boundary or just outside it. However, LiDAR imagery indicates the presence of a structure, suggesting that substantial remains may be in situ.

To ensure the preservation of any potential below-ground archaeological remains, we advise that this area is excluded from planting. Additionally, a 10m buffer should be placed around the feature to further safeguard it. It is also essential that no machinery tracks over this area during woodland creation operations to prevent any potential damage to the archaeological remains.

I have attached an image showing the area of the cottage in purple.
