## Consultation Response for Felling Licence Application – Penboyr Quarry (FLA195 24-25)

## Dear Peter Jones,

Thank you for consulting us regarding the Felling Licence Application for Penboyr Quarry near Maudsland.

Having reviewed our Historic Environment Record (HER) for the area, I note that the information provided in response to consultation FLA 190 21-22 remains relevant. Specifically, the following historic features are recorded within or near the mapped boundaries (See attached map):

- **PRN 15896**: Post-Medieval Quarry (NGR SN3388735063) *Description*: A quarry shown on the historic Ordnance Survey maps (1889, 1906).
- **PRN 125812**: Post-Medieval Quarry (NGR SN33793482) *Description*: A quarry shown on the historic Ordnance Survey maps (1889, 1906).
- **PRN 125811**: Post-Medieval Cottage (NGR SN34083518) *Description*: A cottage and enclosure recorded on the 1st and 2nd edition Ordnance Survey maps (1889, 1907).

The current condition of these features is unknown; however, they may survive as ruins, earthworks, or below-ground archaeology. It is important that felling operations avoid causing damage in these areas.


