Dyfed Archaeological Trust will be consulted on this Screening Advice Note (SAN).

If a Managed Realignment scheme is pursued, then there will be a risk to the known archaeological assets closer to the coastline, whilst also the additional risk of unknown archaeology being disturbed. In any areas where tidal inundation will be allowed to occur then it may be sensible to commission a Desk-Based Study and potential further trial pit surveys.

It is unlikely that SM Assent will be required, however, Cadw should be a close consultee. If the scheme increases flood risk for any of LBs or the Conservation Area, then close consultation with the Carmarthenshire Council will be required.

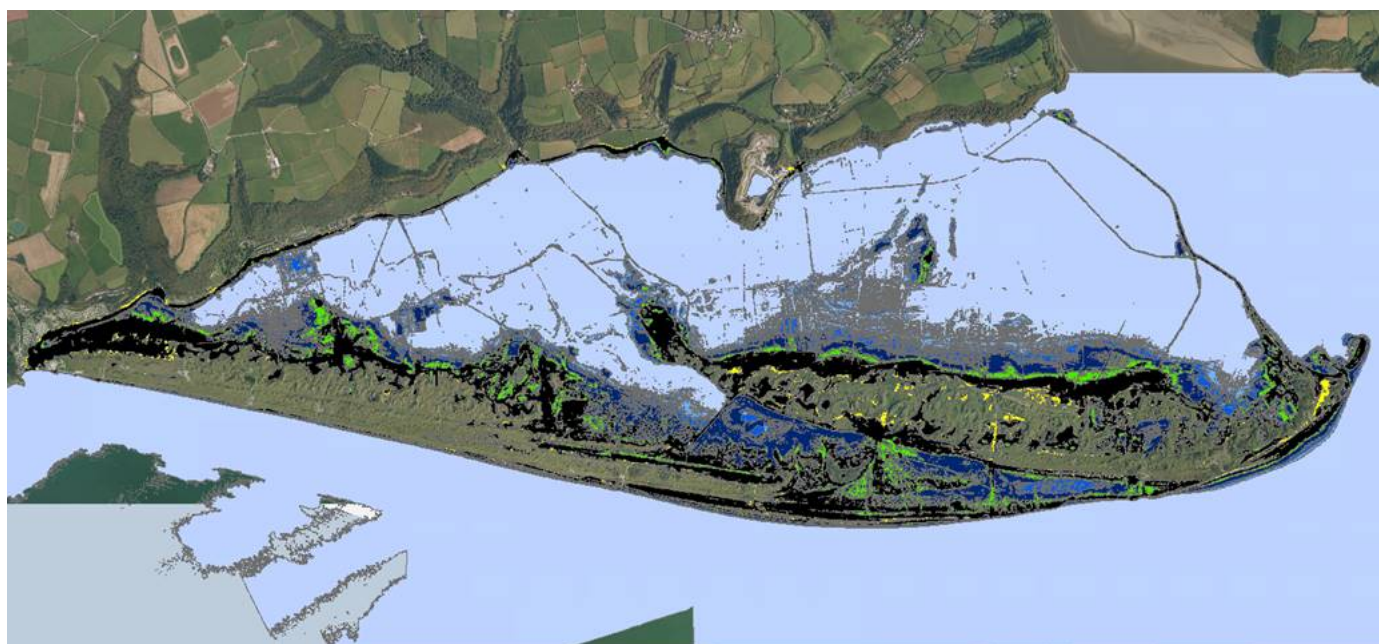
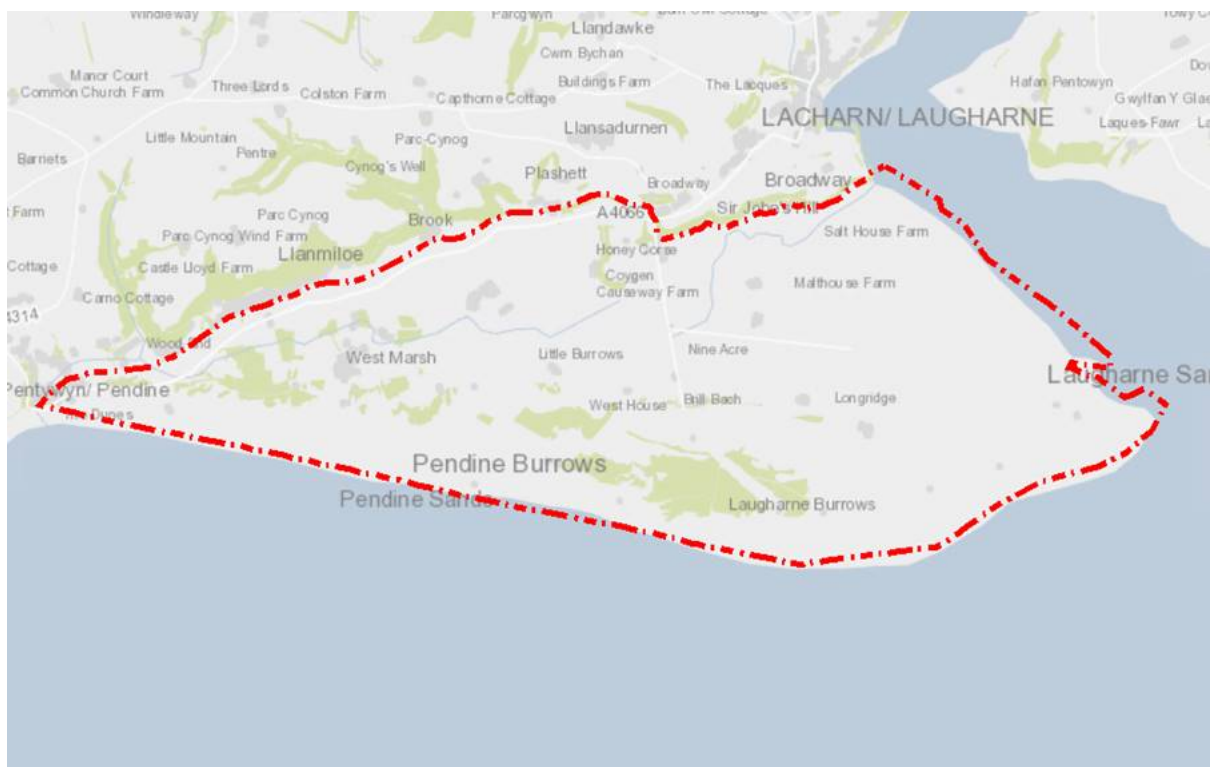
NRW are starting to progress a project to look at coastal management options in the area of Laugharne Lower Marsh SN 29610 08465. The initial study area would be the approximate flood extent shown in blue on the second image. We would like to consult DAT at this early stage under the MoU for our screening arrangements.

From an initial desk study on our GIS, we have made the following observations so far – subject to your input. I could send you the whole of the draft screening note, but it is quite lengthy. Let me know if you would like more information.

Cultural Heritage

There are no Scheduled Monuments (SMs) within the project area, however, Napps Camp SM is proximate to the southwestern boundary of the site, behind the dune habitat. Within the boundary of the project area there are five Listed Buildings (LBs), with three more close to the northern boundary of the site and a number of LBs within the town of Talcharn/Laugharne. Talcharn/Laugharne is also a designated Conservation Area with registered Historic Parks and Gardens at Llanmiloe House and Llargharne Caste, and there are a number of archaeological points of interest (noted on the Historic Environment Record kept by the Welsh Archaeological Trusts) around Laugharne within the site boundary. The site is within the Taf and Tywi Estuary Historic Landscape. See landscape and historic environment designations constraints map in Annex 2.
