

## Hi Arwel,

Thank you for sending the geophysical report for Maesycastell. It's very interesting to see the results of the survey which reveals the potential for further features. The following comments refer specifically to the area around the defended enclosure PRN 842 at Maesycastell and should be considered in addition to the earlier report of 16/03/2023. In line with the conclusions outlined in the report, planting should be avoided from those features which have been identified on the geophysical survey as probable and possible archaeological features. I have annotated the drawing below to indicate where no planting should take place (shown with a purple line).

Thanks for your email.

The rationale for the area shown to be excluded from planting is based on the topography below the enclosure - where the ground levels out is where further archaeological activity might be expected. The steeply sloping ground of the three fields to the south of the enclosure is unlikely to be archaeologically sensitive.

I think the area excluded around the chambered tomb is acceptable.

I'm not in a position to recommend an archaeological contractor to carry out a geophysical survey, but would recommend that they are suitably qualified, skilled and competent persons and abide by the Chartered Institute for Archaeologists (CIfA) Standards and Guidance. 
