## **Pontygafel Farm Morewoods**

## Dear Alison Wheeler,

Thank you for consulting us on the Morewoods application for Pontygafel Farm..

Following a review of the Historic Environment Record (HER) and other available resources, I have identified the following feature:

• **Fynnon-deg:** likely a small farm stead illustrated on 1<sup>st</sup> and 2<sup>nd</sup> edition Ordnance Survey maps, probably of post-Medieval origin.

The current condition of this historic environment feature is unknown; it may survive as ruins, earthworks, or below-ground archaeology.

To prevent potential damage to these historic assets, we advice that planning should be avoided in this area. This feature is marked in purple on the attached map.

Additionally, there is always the possibility that previously unknown remains could survive within this area. Should any further archaeological features or finds be identified during operations, please **inform Heneb – The Trust for Welsh Archaeology, Heritage Management (Dyfed region)** so that we can provide further information and advice as required.


