Advice (If the proposal is considered to be inappropriate at this location please provide an explanation)	PRN: 48337 Parc Maenhir North – Standing/rubbing Stone SN 00667 35860 A well-established (earthfast) possible rubbing stone. .It is located on a slight natural ridge on a south facing sloping, pasture field (rectangular), nearer to the southern boundary. The stone stands 1.5m high and is 0.7m wide x 0.6m thick around its base. Thick lichen growth is present on the stone. Recommendations: A buffer of at least 20m should be maintained around the archaeological feature (marked in orange on the attached map). Although it is described as a rubbing stone in the HER description, it is also possibly to be a Bronze Age standing stone.

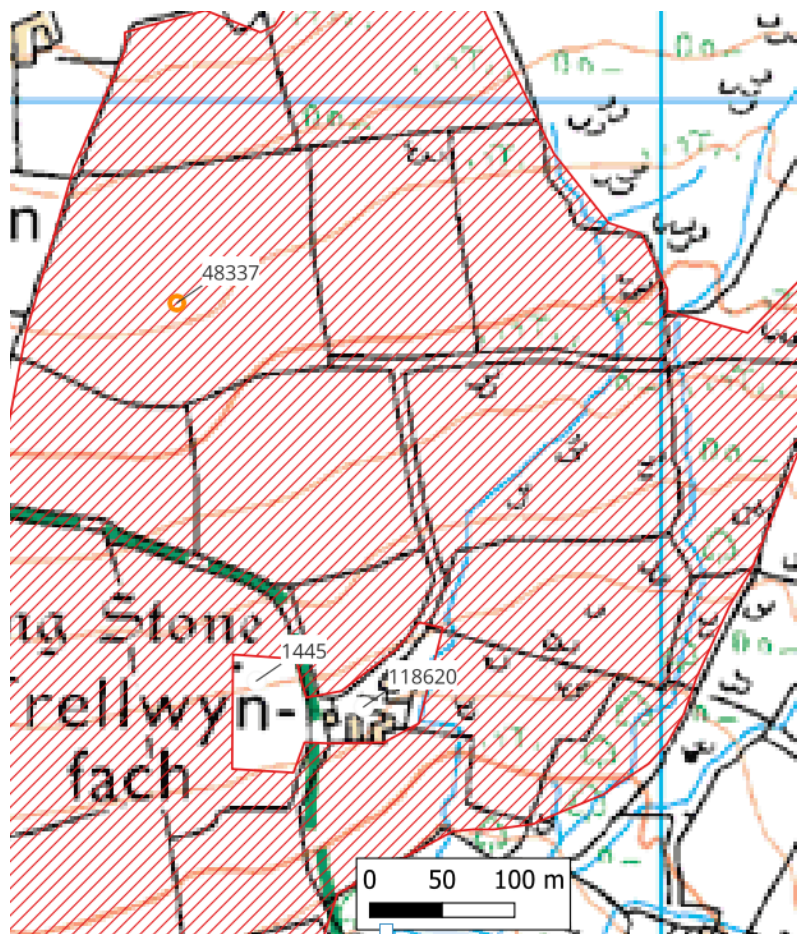
