**PEMBROKESHIRE COUNTY COUNCIL
FOOTPATH NUMBER 2 IN THE COMMUNITY OF ST DOGMAELS DEFINITIVE
MAP MODIFICATION ORDER 2015**

On 23rd November 2017, an Inspector appointed by the Welsh Government confirmed with modifications the above Order.

The effect of the Order as confirmed is to modify the Consolidated Definitive Map and Statement of Public Rights of Way by deleting from them the footpath from point A to point C via point B and from point E to point F and by adding to them the footpath from point A to point C via point D and from point E to point G as shown on the Order Map and as described in the Order Schedule.

A copy of the confirmed Order and the Order Map may be seen free of charge at the County Hall, Haverfordwest, SA61 1TP from 9:00 a.m. to 4:30 p.m. on any weekday. Copies of the Order and map may be bought there at a price of £2.56.

The Order became operative 23rd November 2017 but if any person aggrieved by the Order wants to question its validity, on the ground that it is not within the powers of the Wildlife and Countryside Act 1981, or that any requirements of that Act, or any regulation made thereunder has not been complied with in relation to the Order, he or she may, under Paragraph 12 of the Schedule 15 to the Wildlife and Countryside Act, 1981, within 42 days from the date of publication of the notice under Paragraph 11, make application for the purpose to the High Court.

This Order is made by Pembrokeshire County Council of County Hall, Haverfordwest, Pembrokeshire under Section 53 (2) (b) of the Wildlife and Countryside Act 1981("the Act") because it appears to that Authority that the Consolidated Definitive Map and Statement of Public Rights of Way for the County of Pembrokeshire requires modification in consequence of the occurrence of an event specified in Section 53 (3) (c) (i) and (iii), namely the discovery of evidence which shows that two parts of a right of way at Poppit which are not shown on the map and statement subsists, and that there is no public right of way in two parts over land shown in the map and statement as a public footpath at Poppit.

The Authority has consulted with every local authority whose area includes the land to which the Order relates. The Pembrokeshire County Council hereby order that;

1. For the purpose of this Order the relevant date is 8th May 2015.
2. The Consolidated Definitive Map and Statement for the County of Pembrokeshire shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
3. This Order shall take effect on the date it is confirmed and may be cited as the Pembrokeshire County Council Public Footpath number 3 in the Community of St Dogmaels Definitive Map Modification Order 2015. 2

PART 1

MODIFICATION OF CONSOLIDATED DEFINITIVE MAP
DESCRIPTION OF PATH OR WAY TO BE DELETED

- a) From point A (OS grid reference SN1431549124) via point B (OS grid reference SN1432449133) to point C (OS grid reference SN1432649147) as shown on the Order Map by a continuous bold black line for a total length approximately 28 metres.
- b) From point E (OS grid reference SN1435749175) to point F (OS grid reference SN1442649148) as shown on the Order Map by a continuous bold black line for a total length approximately 81 metres.

DESCRIPTION OF PATH OR WAY TO BE ADDED

- a) From point A (OS grid reference SN1431549124) via point D (OS grid reference SN1431649137) to point C (OS grid reference SN1432649147) as shown on the Order Map by a broken bold black line for a total distance of approximately 28 metres, *having a width of 1.2 metres.*
- b) From point E (OS grid reference SN1435749175) to point G (OS grid reference SN1436449145) as shown on the Order Map by a broken bold black line for a total distance of approximately 38 metres, *having a width varying between 1.1 and 1.4 metres.*

PART II

MODIFICATION OF DEFINITIVE STATEMENT
VARIATION OF PARTICULARS OF PATH OR WAY

Footpath leaves the unclassified County Road at Cnwcau and descends steeply to Penrhyn-bach where the path continues to follow the access to Penrhyn and Penrhyn Castle at OS grid reference SN1427749111 where the path turns north east for approximately 39 metres to OS grid reference SN1431549124 and continuing in a general north east direction via OS grid reference SN1431649137 to OS grid reference SN1432649147 for approximately 28 metres. Descending in a general north east direction to SN1435749175 where the path turns in a southerly direction and descends a flight of steps on reaching Cei-bach the path turns east to terminate at the mean high water mark at OS grid reference SN1436449145.

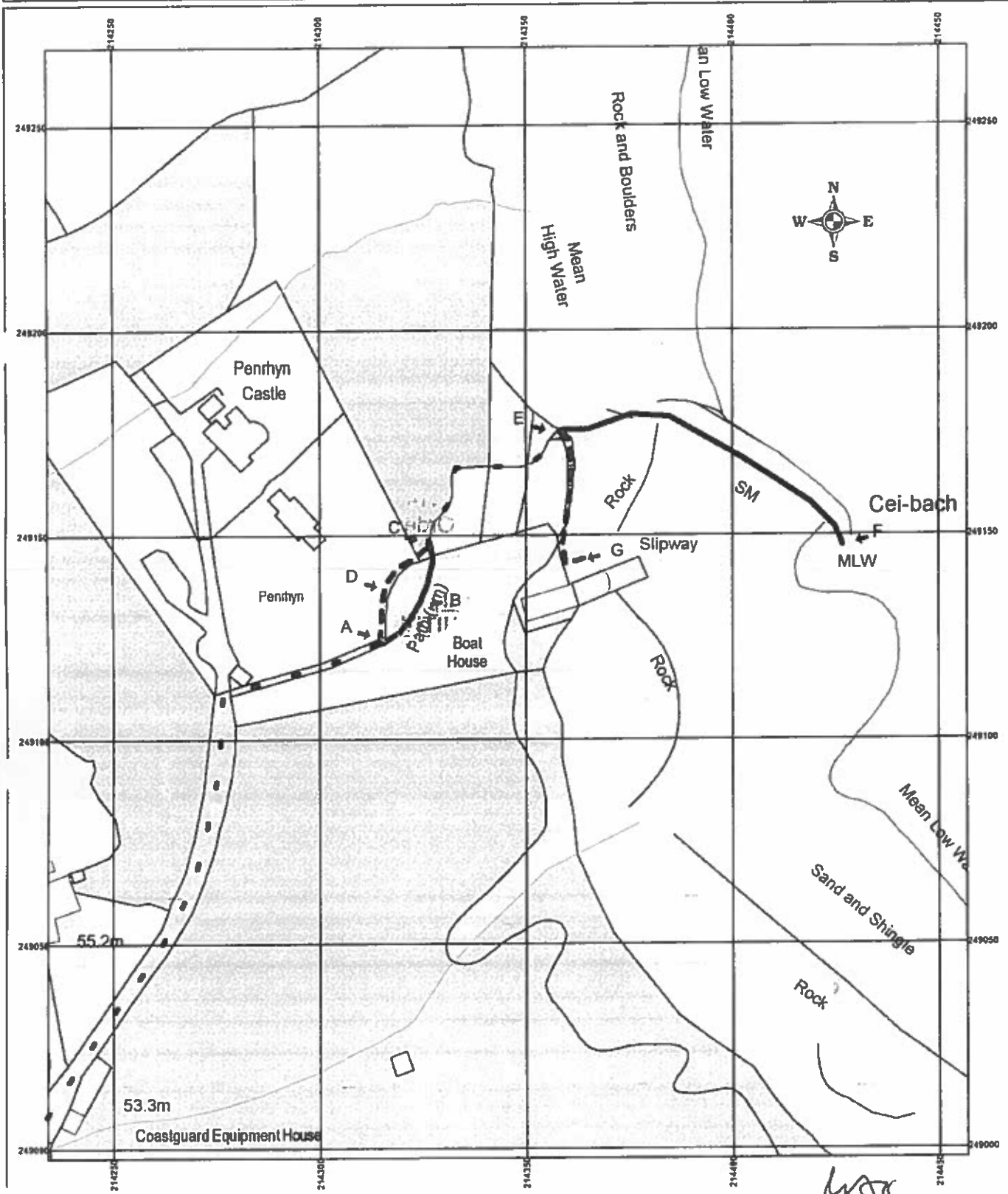
