## HIGHWAYS ACT 1980 SECTION. 119 PEMBROKESHIRE COAST NATIONAL PARK AUTHORITY PUBLIC FOOTPATH PP87/40 (PART) IN THE COMMUNITY OF NEVERN, PEMBROKESHIRE PROPOSED PUBLIC PATH DIVERSION ORDER 2017

The National Park Authority is consulting on its proposal to divert part of public footpath PP87/40, as shown on the enclosed plan.

The existing route of the public footpath starts at the roadside just north of the bridge over the Nant Ceibwr stream and passes the dwelling at Glyn yr Efail to climb the northern slope of Cwm Trewyddel. It then enters a pasture field to run across several other fields in a north easterly direction to Pantsaeson. As the public footpath traverses a very steep and long gradient on the northern slope of Cwm Trewyddel, the National Park Authority is seeking to manage an alternative route that would be more accessible for the public.

The alternative route would start from a point further north along the road and run alongside a hedge bank in a wooded area to join the existing route, at a point where it enters the pasture field. By comparison to the existing route, this footpath is reasonably level, affords fine views west along Cwm Trewyddel and links conveniently to the nearby public footpath (PP87/56), which heads west along Cwm Trewyddel to the coast. There is some walking entailed along a minor road when approaching the alternative route from the south but this provides a much easier assent of the slope for pedestrians.

I should be pleased if you would consider the proposal and let me have your views, using the enclosed plans to illustrate them if you wish. Representations should be made in writing by Friday the 28<sup>th</sup> April 2017. If you require further information or need longer to consider this proposal, please do not hesitate to contact me.
