PUBLIC PATH DIVERSION ORDER HIGHWAYS ACT 1980 PEMBROKESHIRE COUNTY COUNCIL

The Pembrokeshire County Council Public Footpath No. SP/10/24 (part) West Llanteg (Part) in the Community of Amroth - Diversion Order 2018

This Order is made by the Pembrokeshire County Council ("the authority") under section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interests of the owner of the land crossed by the footpath described in paragraph 1 of this Order, it is expedient that the line of the path should be diverted.

The Applicant has agreed to defray any expenses which are incurred in bringing the new site of the path into a fit condition for use by the public.

Amroth Community Council has been consulted as required by Section 120(2) of the 1980 Act.

BY THIS ORDER:-

- 1. The public right of way over the land situated at West Llanteg Farm, Llanteg, Narberth, Pembrokeshire and shown by a bold continuous line on the map contained in this Order and described in Part 1 of the Schedule to this Order shall be stopped up after 14 days from the date of confirmation of this Order.
- 2. There shall at the end of 7 days from the date of confirmation of this Order be a public footpath over the land situated at West Llanteg Farm (aforesaid) as described in Part 2 of the Schedule and shown by a bold broken line on the map contained in this Order
- 3. Notwithstanding paragraph 1 of this Order British Telecom shall have the same rights over the land referred to in paragraph 1 above, in respect of their apparatus under, in, upon, over, along, or across the said land as they had immediately before the date of confirmation of this Order.

SCHEDULE

PART 1 **DESCRIPTION OF SITE OF EXISTING PATH**

From point A (Grid Reference SN18111042) in a westerly direction for approximately 32 metres to point B (Grid Reference SN18071043) then in a generally south westerly direction for approximately 52 metres to point C (Grid Reference SN18031039). The total distance is approximately 84 metres. Width undefined.

PART 2 **DESCRIPTION OF SITE OF NEW PATH OR WAY**

From point E (Grid Reference SN18091047) along a farm track in a generally west south westerly direction for approximately 65 metres to point F (Grid Reference SN18021045) then following the field margin in a generally south south easterly direction then generally south westerly for approximately 63 metres to point C (Grid Reference SN18031039). The total distance is approximately 128 meters and the path has a width of 2 meters throughout.
