

Summary

Archaeology Wales (AW) was commissioned by Clarke Telecom to carry out a Heritage Impact Assessment and site visit on land at Ogwen Cottage, Bethesda LL57 3LZ (centred on NGR SH 65001 60668). This assessment is made in relation to a proposal for the erection of a 15m high timber clad monopole supporting three antennas and two dish antennas together with ground-based equipment cabinets and VSAT dish on land adjacent to Ogwen Car Park, Nant Ffrancon, Bethesda.

The guidance offered within Managing Heritage Impact Assessment in Wales (Cadw 2017) has been utilised within this assessment, which advocates examining the Evidential, Historical, Aesthetic and Communal values of the historic assets. Two particular heritage assets had been identified in this instance: The scheduled Monument CN338 The Holyhead Road: the Ogwen Pass and the scheduled monument CN399 Nant Ffrancon Anti-invasion Defences. The impact on the Ogwen Valley Historic Landscape Character Area – HLW (Gw) 10 is also considered.

The proposed development site comprises a 6m x 6m square area located within woodland on a 19th century spoil heap derived from a local slate quarry. As such the site has low to medium evidential and historic value at present, due to the absence of recorded archaeological sites within its curtilage. Nevertheless, its close association with nationally importance scheduled monuments suggest that its archaeological potential may be higher. The site lies within both a designated historic landscape and a National Park, giving it a high aesthetic value. As part of these landscapes, it contributes to the aesthetic setting for the scheduled monuments close to the site. The communal value of the site is also high. The site is located on the edge of a busy car park on a major trunk road (A5 Holyhead Road) with open public access to the site and from the site to the designated heritage assets close by.

However, the proposed development will only lightly impact upon some of these values. The design means that most of the development will be hidden from view of the heritage assets and so have little or no impact on the above values. Only the top 6m of the mast will be visible, but this will be wooden clad below the antennae and in keeping with wooden telegraph poles that already occupy the scheduled monument sites. The development may still impact on the sub-surface archaeological potential, but this can be offset by suitable archaeological mitigation providing the opportunity to enhance the historic and evidential value of the site through archaeological recording.

1. Introduction

- 1.1.1 Archaeology Wales (AW) was commissioned by Clarke Telecom to carry out a Heritage Impact Assessment (HIA) and site visit on land at Ogwen Cottage, Bethesda LL57 3LZ (henceforth "the site"), centred on NGR SH 65001 60668 (Figures 1 & 2).
- 1.1.2 This assessment is made in relation to a proposal for the erection of a 15m high timber clad monopole supporting three antennas and two dish antennas together with ground-based equipment cabinets and ancillary development on land adjacent to Ogwen Car Park, Nant Ffrancon, Bethesda (Figure 3). The local planning authority is Snowdonia National Park Authority (SNPA). The planning application (NP3/16/28) is currently on consultation stage. CADW has recommended that:

The application area is located inside 50m of both scheduled monument, CN338 The Holyhead Road: the Ogwen Pass and the scheduled monument CN399 Nant Ffrancon Anti-invasion Defences: However no assessment of the impact of the proposed mast on the settings of these nationally important monuments has been provided with this application. This will be a material consideration in the determination of this application (see Planning Policy Wales 2018 section 6.1.23): However no information on this issue has been submitted with the application and therefore we are currently not in a position to provide yourselves with advice.

Consequently we advise you to request more details of the proposed development to be provided. This will require an assessment of the impact of the proposed development on the setting of the scheduled monument to be prepared in accordance with the methodology outlined in the Welsh Government's best-practice guidance Setting of Historic Assets in Wales (2017). Once this information has been submitted we should be re-consulted on this application.

1.1.3 This HIA has been undertaken to assess the impact of the proposal on the historic environment and to provide SNPA with the information they are likely to need in respect of the proposed development, the requirements for which are set out in a number of policies outlined in Section 3.1. This assessment has been prepared in accordance with the guidance laid out within Managing Heritage Impact Assessment in Wales, produced by Cadw in May 2017.

2. Site description and development details (Figures 1-3)

- 2.1 The site is located immediately north of Idwal Youth Hostel car park, which is in turn located west of Afon Idwal. Entrance to the site can be gained from the A5, through the youth hostel car park (Figure 1).
- The site is located within a densely wooded area, approximately 361m above Ordnance Datum. The proposed development footprint will occupy a 6m x 6m square area centred on NGR SH 65001 60668.
- 2.3 The underlying geology comprises rocks of the Llanvirn Series (mudstone, siltstone and sandstone) formed during the Ordovician Period (BGS 2019). The superficial deposits comprise loose angular slate or scree deposited during the 19th century as spoil from a nearby hone stone quarry.

2.4 The proposed development includes the erection of a 15m high timber clad mast at the centre as well as the construction of a Blenheim cabinet, Power cabinet and a VSAT dish contained within a 2m high timber compound.

3. Legislation & Methodology

- 3.1 Applications for planning permission are considered in light of the Welsh Government's land use planning policy and guidance contained in Planning Policy Wales (PPW), Technical Advice Notes and related guidance. PPW (Chapter 6 The Historic Environment) explains that It is important that the planning system looks to protect, conserve and enhance the significance of historic assets. This will include consideration of the setting of an historic asset which might extend beyond its curtilage. Any change that impacts on an historic asset or its setting should be managed in a sensitive and sustainable way.
- 3.2 The conservation of archaeological remains and their settings is a material consideration in determining a planning application, whether those remains are a scheduled monument or not. Where nationally important archaeological remains are likely to be affected by proposed development, there should be a presumption in favour of their physical protection in situ. It will only be in exceptional circumstances that planning permission will be granted if development would result in a direct, adverse impact on a scheduled monument (or an archaeological site shown to be of national importance).
- 3.3 Technical Advice Note 24: The Historic Environment elaborates by explaining that when considering development proposals that affect scheduled monuments or other nationally important archaeological remains, there should be a presumption in favour of their physical preservation in situ, i.e. a presumption against proposals which would involve significant alteration or cause damage, or would have a significant adverse impact causing harm within the setting of the remains.

4. Method

- 4.1 The objective is to assess the impact of the development proposals on the historic environment by means of the HIA and Site Visit. This work will be undertaken following the guidance laid out within Managing Heritage Impact Assessment in Wales, produced by Cadw in May 2017.
- It will take full account of the merits of the existing buildings, including designated heritage assets and their settings. It will gather enough information to understand the significance of any heritage assets affected and assess the impact of the proposals on those assets. This will help inform future decision making, design solutions and potential mitigation strategies.
- 4.3 The report will provide information of sufficient detail to allow informed planning decisions to be made; it will establish the historical significance of the asset, and its relationship to the wider historical environment.

- 4.4 The assessment will consider the following:
- a) The significance of the site within the landscape and existing structures and their setting, including views and their relationship to adjacent and non-designated heritage assets, through assessment of various readily available primary sources:
 - 1. Collation and assessment of all relevant information held in the regional Historic Environment Record (HER) at GAT-HER. All designated sites within a 2km search radius will be considered (Figure 3). All non-designated sites within a 1km search radius from a central point within the proposed development site will be considered (Figure 2-3).
 - 2. Assessment of all available reports and archives including unpublished and unprocessed material affecting the site and its setting.
 - 3. Assessment of all relevant extant photographic evidence, including available historic photos.
 - 4. All sources indexed in the County Archives as appropriate, site files held by the RCAHMW.
 - 5. Map regression analysis using all relevant cartographic sources e.g. all editions of the Ordnance Survey County Series, tithe and early estate maps (as available).
 - 6. Place name evidence.
 - 7. Historic documents (e.g. Charters, registers, estate papers).
- b) The potential impact of any proposed development on existing historical assets and their setting.

5. Non-designated assets – historic background (Figure 4)

In order to provide sufficient information to apprise nature of the archaeological resource within the immediacies of the proposed site, a search of the Historic Environment Record (HER) was undertaken. This included all sites and events recorded within a 1km radius of SH 65001 60668. The search produced 56 records summarised below in chronological order (Figure 4).

Prehistoric: Palaeolithic (c.450,000 – 10,000 BC), Mesolithic (c.10,000 – 4400 BC), Neolithic (4400 BC – 2300 BC), Bronze Age (2300 BC – 700 BC) & Iron Age (700 BC – AD 43)

- An examination of the wider area of the Ogwen Valley has highlighted evidence for prehistoric activity including: traces of prehistoric field systems and hut groups, as well as hillforts and burial activity, dating to the Neolithic and Bronze Age. Within the selected area, prehistoric activity appears to be concentrated on the shores of Llyn Ogwen and Llyn Idwal.
- 5.3 Several prehistoric findspots were identified during a survey conducted by Engineering Archaeological Services Ltd (EAS), at the request of the National Trust, in 2015 on the shores of Llyn Idwal (PRN E45124). The recovered artefact assemblages included broken blades and bladelets and possible awl fragment (PRNs 71264-5) (Brooks 2015). The survey also revealed two circular anomalies tentatively interpreted as round houses to the east of Llyn Idwal (PRN 71266 and 71258), and a possible Bronze Age boundary wall (PRN 71259).

- 5.4 The remains of two hut circle settlements are known to exist on the north and south sides of Llyn Ogwen (PRNs 5008 and 5006 respectively). No excavation of these sites is recorded on the HER database; however, they have been surveyed on two occasions. The first was during the Hut Circle Settlement Survey (Smith, 1998) and, the second as part of the Early Celtic Societies in North Wales (Waddington, 2010).
- 5.5 A looped bronze palstave (Needham period 6) dating to c. 1150-950 BC was recovered by a climber at Pen Yr Ole Wen, northeast of the proposed development site (PRN 24018; Portable Antiquities Scheme GAT-C5BC97).

Roman (AD 43 - c. AD 410)

- The region of Snowdonia was conquered by the Romans in AD 77-78. Material evidence of the campaigns have survived in the form of marching and practice camps such as that at Caer Llugy, 12.5km SE of the development site. The Roman Military also established a network of roads connecting the forts.
- 5.7 In 1999, Waddlelove theorised the approximate route of the Caer Llugwy Bangor Roman Road (PRN 17819). This is assumed to run from Caer Llugwy to Penrhyn along a line approximately followed by that of the old coach road; the turnpike through Nant y Benglog along the west side of the Nant Ffrancon. The projected line runs c. 58m south of the proposed development site on an east to west direction.

Early Medieval (c. AD 410 – AD 1086) & Medieval (1086 – 1536)

5.8 Evidence for medieval activity within the search area is limited to a bridge, *Pont Pen-y-benglog*, 23m north of the proposed development site. This is described in the HER as a medieval bridge located beneath the road bridge over the Afon Ogwen. It is 2.3m wide, has a span of 47m and is constructed of flat undressed stones set radially around an arch which rises some 1.6m at its centre. (PRN 2340; see also listed building 22944).

Post-Medieval (1536 - 1899)

- 5.9 Several HER records echo the significance of this area for the extraction of mineral resources during the post-medieval period. It is estimated that during its peak, extraction surpassed 485,000 tonnes per annum and employed more than 17,000 people. The proposed development area is close to a former hone stone guarry.
- 5.10 Pen y Benglog quarry (PRN 20804) is located c. 100m south from the proposed development site. Spoil heaps relating to this quarry appear to be marked on historic maps dating from 1889 to the 1950s (Figures 8-10) on which they appear to stretch as far as the proposed development site. This slate quarry is catalogued in the *Gwynedd Metal Mines Survey* (Gwyn, 1998).
- 5.11 A copper trial mine (PRN 20810) is documented at *Bwlch Y Nant*, also catalogued in the *Gwynedd Metal Mines Survey* along with a further quarry south of Llyn Ogwen (ibid).
- 5.12 The rural nature of the area is also reflected in the historic environment record. Three sheepfolds are recorded within the applied search area. The first (PRN 27188) is in the

community of Llandygai and, although it has been referred to as a sheepfold on historic maps, it is catalogued as a house by a National Trust Survey (Kenney 2014). The second sheepfold (PRN27193), also located in Llandygai, is also documented in historical maps dating from the 1889 onwards. The third (PRN 71254) is located to the east of Llyn Idwal, recorded during the 2015 survey of Cwm Idwal (Brooks 2015), along with a boundary wall. Other features recorded by this survey include a rectangular building (PRN 71251) and associated paddocks (PRN 71252). Furthermore, both the RCAHMW and the HER record the presence of a 19th century barn-cum- byre and associated bridge at Llandygai (PRN 64193, NPRN 418713 – see listed building 23455 for further details).

- 5.13 The HER also documents a number of milestones: PRN 29199 (see listed building 22923); PRN 64645 (see listed building 22923), and a turnpike road (PRN 58539; NPRN 418712) which is now followed by the A5 (Davidson 2014).
- 5.14 The remains of a boat house to the east of Llyn Idwal are also recorded on the HER, marked on OS maps until the 1920s (Brooks 2015).

Modern 1900 -

- 5.15 The proposed development area and its immediate environs have been greatly affected by the response of the civil and military mobilisation to the threat of German invasion during the 1940-1.
- 5.16 Spigot mortars were anti-tank weapons devised during the early years of the 1940s. These weapons have emplacements which have resisted the passage of time and still, in many instances, characterise the cultural landscape of the area. The emplacements, as well as all other war related structures defined below, protected routes such as the former turnpike road described in section 5.11 above.
- 5.17 Nine spigot mortar emplacements are documented within the search area, six of which are scheduled as part of SAM CN399. Together they formed a section of the Western command Stop Line 23 (SAM CN399; NPRNs 270747-9, 270451). The surviving scheduled structures include two pillboxes (NPRN 418763 and NPRN 270452), six spigot mortar emplacements (NPRNs 419778, 270451, 270349, 270449, 419780), three infantry positions and an incomplete alignment of eight anti-tank blocks (NPRN 270450).

<u>Unknown</u>

5.18 The following table itemises all HER records of unknown date. They emphasise the rural nature of the proposed development area and its surroundings and, though no date is attributed to them, although they are likely post-medieval/modern in date.

6. Designated Assets

6.1 A search was conducted for designated heritage assets located within 2km of the proposed development site

Conservation Area

6.2 The proposed development site is not located within a Conservation Area. Similarly, there are no Conservation Areas within the 2km applied search area. The closest Conservation Area is *Nant Peris*, located 4.7km to the SW.

Landscapes (Figure 5)

- 6.3 The proposed development site is located within the Ogwen Valley Historic Landscape Character Area HLW (Gw) 10.
- Topographically, the northern part of the Ogwen valley is deeply glaciated. The valley floor lies at about 200m aOD while the peaks raise up to a maximum of 1044m aOD. The region contains relics of prehistoric and later land use which are in stark contrast with the landscapes created by the post-medieval slate extraction. There are a number of Bronze Age burnt mounds, enclosures, field systems and Iron Age Hillforts as well as medieval settlement. Post-medieval remains include quarry trials and levels, hone-stone quarries and dry-stone walled sheepfolds.
- 6.5 The area is dominated by the Penrhyn quarry which remained the largest in the world until the 1960s. The commercial development of the slate industry owed much to Richard Pennant of Penrhyn who acquired multiple quarries in the area by the 18th century.

- 6.6 The area includes parts of Cwm Idwal National Natural Reserve and Glydeiriau Sites of Special Scientific Interest.
- 6.7 The landscape is historically significant due to its classic glaciated valley, containing contrasting evidence of prehistoric and later land use, superimposed by the extensive and visually dramatic remains of the recent and continuing industrial exploitation of slate. The area includes: Neolithic and Bronze Age funerary and ritual monuments; Iron Age hillforts and concentrations of relict settlements and field systems; medieval settlements; large and extensive remains of 19th and 20th centuries slate quarries, tips, attendant settlements and transport systems; Penrhyn Castle and Park; Telford's Holyhead Road; historic literary and social associations (RLOHIW 1998).

Parks and Gardens

6.8 The proposed development site is not located within a Registered Park and Garden. Similarly, there are no Parks and Gardens within the 2km applied search area. The closest Registered Park and Garden is Bryn Bas Castle – GD 41 – located 10km to the WNW.

Scheduled Monuments (Figure 6)

- 6.9 No Schedule Ancient Monuments are located within the proposed development area. Two Scheduled Ancient Monuments are recorded within the applied search area.
- Nant Ffrancon Anti-invasion defences (CN399) formed part of the WWII home front defence 6.10 network that covered the whole of the UK. It is classed as an anti-invasion defence site and formed part of the Western Command Stop line number 23 which ran from Bangor in the north toward Porthmadog in the south. The defences at Nant Ffrancon, as they survive, consist of six spigot mortar emplacements (NPRNs 419778, 270451, 270349, 270449, 419780), two pillboxes (NPRN 418763 and NPRN 270452), three infantry positions and an unfinished section of anti-tank defences consisting of block-built stone "Dragon's Teeth". The area is located toward the southern end of the Ogwen Pass just to the west of Llyn Ogwen. This route between Bethesda to the north west and Capel Curig to the south east has provided important access thru the mountains of north west wales since at least the 18th century, and potentially since the 1st century AD. One of the two pillboxes (NPRN 270452) was built upon the remains of an earlier structure, probably a sheepfold which is shown on historical OS maps (1:10000 series). The earlier structure consisted of stone walls enclosing a small yard, whilst the pillbox is constructed of reinforced concrete sheets covered with turves and stones, and a rammed earthen floor. Within the structure the remains of a bunk bed survived at the time of the survey. It has gun embrasures on the northern and southern sides as well as two others on the NE and NW corners and it commanded good views over the roadway to its east. The spigot mortar emplacements are constructed of concrete built pedestals on circular bases with stainless steel mortar mounts atop them. The infantry positions are unbonded stone-built structures. The monument is considered to be of national importance for our understanding of anti-invasion measures used during WWII.
- The Ogwen Pass scheduled ancient monument (CN338) comprises the remains of a revetment or major routeway running through the mountains in North Wales between Bethesda and Capel Curig and dates from the early 19th century. The site consists of a stretch of walling forming a revetment for the Holyhead Road (NPRN 402349) built by Thomas Telford on the eastern flank of Nant Ffrancon near to Llyn Ogwen and an earlier turnpike road (NPRN 418712) visible nearby. The road, originally a toll road, formed part of an extensive transport link

between London and Ireland. This section was constructed between 1815-1819. There were two earlier routeways that ran through the area. Richard Pennant (1st Baron Penrhyn, 1737-1808) had a road built circa 1791 along the south west side of the valley; whilst a turnpike was built on the north eastern side of the valley circa 1801. The modern A5 trunk road now runs along this route.

Listed Buildings (Figure 7)

6.12 No Listed Buildings lie within the bounds of the proposed development site. Eight listed buildings are located within the applied search area. A summary of the buildings documented is provided below:

Pentre Farmhouse and stables - LB 23358-9

- 6.13 Two storey, 3-bay front, farmhouse likely built in 1850 in Ogwen Valley during the expansion of farming in the region, much of which was sponsored by the Penrhyn Estate. The farmhouse is rendered rubblestone with a slate roof and painted front. The ground floor front has a slightly offset entrance with 20th century boarded door and lean-to porch, with five 6-pane sash windows across the ground and first floors. The farmhouse sits upon the so-called "old road" along with several other farms. This road once formed the main road through Ogwen Valley (superseded by the construction of the turnpike road on the opposite side of the valley in 1802).
- 6.14 The stables possibly represent the original dwelling at the farmstead, and as such is an important surviving simple dwelling house associated with the colonisation of marginal agricultural land, currently used as a shepherd's hut with a small integral fireplace and mantle shelf. The exterior consists of roughly coursed rubblestone with slate roof, the front of which has an off-centred door flanked by eaves windows, with a reflected arrangement at the rear elevation.
- 6.15 The cowsheds are contemporary with the farmhouse at Pentre Farm which was built 1850 on the opposite side of the road. Both sheds are set into the hillside. The south-eastern cowshed is the longer of the two with its north-eastern gable end projecting beyond the other cowshed. The upper parts of the south-west gable end of both sheds are roughly at road level.

Cowshed to East of Blaen-y-nant – LB 23455

6.16 This structure was built in the mid-19th century as a field cowshed, likely originally associated with the farmhouse at Blaen-y-nant. The detached building forms a distinctive feature in the landscape. It is rectangular in plan, aligned approximately north-south, with a roughly coursed rubblestone and slate roof exterior. The eastern elevation has three evenly spaced doors and a small window to the left. There is a boarded hatch to the hayloft in the south gable end.

Milestone – LB 22922

6.17 One of a series of milestones erected on Thomas Telford's nationally important London to Holyhead road. This turnpike road was established between 1815 and 1830. The milestone is constructed from limestone, tapered with chamfered edges and inset tapered top. It has a cast-iron plate of the same shape which reads "Holy-/ Head/ 33/ Bangor/ 8/ C. Curig/ 6M – 3F". The milestone is situated on the eastern side of the A5 approx. 320m south-east of Braichty-du built into a low rubblestone field boundary wall.

Milestone – LB 22923

6.18 This milestone is situated on the eastern side of the A5 approximately 120m north-west of Pont Pen-y-benglog, set directly into a low rubblestone field boundary wall. It is part of the series of milestones erected on Thomas Telford's London to Holyhead road. The milestone is a limestone tapering slab with chamfered edges and inset tapered top. A cast-iron plate of the same shape reads "HOLY-/ HEAD/ 34/ BANGOR/ 9/ C. CURIG/ 5M - 3F"

Field Cowhouse – LB 22924

6.19 This cowhouse was built in the mid-19th century and is likely originally associated with the farmstead of Braich-ty-du and sits detached in the fields. It is rectangular in plan with a rough coursed rubblestone exterior and slate roof. A low rubblestone wall forms small corralled area in the front of the north-gable end. The cowhouse is a characteristic agricultural structure of the region and period.

Pont Pen-y-benglog - LB 22944

6.20 This small late 18th century bridge sits underneath the main bridge on its widened eastern side. This widening took place in 1928, before which the original bridge stood alongside a larger and taller bridge, built by Thomas Telford in the 1820s, as part of the turnpiking of the London to Holyhead road between 1815 and 1830. The original bridge consists of the small single-span segmental-arched rubblestone structure at the eastern side of the bridge.

7. Map regression

Ordnance Survey County Series, Caernaryonshire 1889, 1.2500 (Figure 8)

7.1 This map documents the proposed development area as rough pasture, located within the valley and surrounded by steep peaks. Several large rocky outcrops are shown immediately south of the site. Furthermore, the area contains several raised elongated mounds interpreted as spoil heaps resulting from slate extraction at Pen y Benglog quarry (PRN 20804). Ogwen Cottage and a number of associated structures are located to the east of the quarry adjacent to Llyn Ogwen. The turnpike road (PRN 58539; NPRN 418712) is also shown on this map running NNW/SSE, east of the proposed development site.

Ordnance Survey County Series, Caernarvonshire 1900, 1.2500 (Figure 9)

7.2 This map shows little change from the 1889 edition. The steep slopes immediately west of the proposed development site now comprise mixed woodland, and the site itself appears to be more densely vegetated. The slate quarry spoil heaps are still evident on this map. This map also shows Glanrhyd-Idwal School and Mission Room (NPRN 97131) for the first time.

Ordnance Survey County Series, Caernarvonshire 1914, 1.2500 (Figure 10)

7.3 A similar situation is depicted on the 1914 edition. However, at this point, the proposed development area appears to be more densely wooded. Furthermore, the position of Benglog Cottage is occupied by a large building labelled as Idwal Cottage and quarry.

Ordnance Survey. Six-inch to the mile Caernarvonshire XVII.NE 1934

7.4 No differences are observed between this map and the 1914 map edition.

Ordnance Survey. Six-inch to the mile Caernarvonshire XVII.NE 1953

7.5 No substantial differences are observed between this map and the 1934 map edition.

8. LiDAR imagery

- 8.1 Im DTM and DSM was used to obtain results for the proposed development site. The DSM data was used to obtain an accurate view of the topography of the area, whilst the DTM was also plotted to obtain a view of possible surface anomalies (Figure 11).
- 8.2 No earthworks of archaeological origin were observed during the evaluation of the processed plot. However, the imagery has enabled the character of the valley and the surrounding area to be more fully defined.

9. Aerial photography

9.1 No noteworthy information regarding the site was obtained during the examination of aerial photographs given its wooded nature. However, a number of images are discussed below which either show the area of the proposed development site and surroundings or offer close-up views of the surrounding historic environment.

RAF - Nant Francon - 106 GUK/33/24.03.1945 - 542 SQDN

9.2 This photograph shows the proposed development area as well as its surroundings. The site is defined by dense woodland with rocky outcrops located within. Several spigot emplacements are also noticeable.

NMR Site Files 1947 - Catalogue Number C591593

9.3 This photograph documents the remains of a hut circle at Pen Y Ben (PRN 761; NPRN 302882). The hut only remains as a low outcrop partially defined by the remains of dry-stone walls.

RCAHMW Colour Oblique Digital Aerial Photographs 2011 - Catalogue Number AP 2011 2851

9.4 This photograph shows the proposed development site as densely wooded, so it is not possible to discern details about any possible archaeology contained within. Nevertheless, the image shows the A5 which follows the route of the Ogwen Pass (NPRN 402351). Idwal Youth Hostel and its associated car park can also be seen on this photograph.

RCAHMW Colour Oblique Digital Aerial Photographs 2012 – Catalogue Number C917740

9.5 This photograph documents two hut circles (CN269; PRN 5006; NPRN 417137) located south of Llyn Ogwen. The remains are c. 7m in dimeter and are defined by dry stone walls.

Google Earth – historic collection

9.6 Historic Imagery of the area is available on Google Earth from September 2003 onwards. The development site is wooded, although parts of the woodland have been appropriated for the national Trust car park and Carneddau and Glyderau visitor centre at Ogwen Cottage.

10. Site visit

- 10.1 A site visit was undertaken as part of the Heritage Impact Assessment (HIA) on 13th November 2019, by Jerry Bond BA and Erika Guttmann-Bond PhD (AW). The weather was cold, with mixed cloud, sunshine & occasional mist. Visibility was generally good.
- 10.2 The site is located at the western end of Llyn Ogwen, just to the NW of Ogwen cottage, among a stand of trees situated to the north of the National Trust carpark for the Carneddau and Glyderau visitor centre. The site location, within mature woodland, serves to mask it from much of the surrounding landscape and neighbouring heritage assets. Nevertheless, the height of the proposed mast when constructed (15m) means that its upper section would be visible above the tree cover. The site lies in close proximity with two scheduled ancient monuments; the WWII defences of Nant Francon (CN399) and the Holyhead Road: the Ogwen Pass (CN338). The former comprises several disparate elements spread over an area measuring approximately 700m east west by 300m north south. These include six spigot mortar emplacements (NPRNs 419778, 270451, 270349, 270449, 419780), two pillboxes (NPRN 418763 and NPRN 270452), three infantry positions and an unfinished section of antitank defences. The proposed development site lies at the eastern end of this complex. It was the purpose of the site visit to assess the visual impact that the development may have on the setting of these monuments.
- 10.3 The site was initially viewed from the eastern end of llyn Ogwen, (plate 1) and then also from the layby on its central southern shore (plate 2) from where Ogwen cottage could be seen, as well as the trees marking the proposed development site.
- 10.4 Plate 3 provides a view northwest along the Nant Ffrancon valley from close to the proposed development site. The view is specifically from a point slightly to the west, next to one of the WWII spigot mortar mounts (PRN29569), part of the scheduled WWII defences of Nant Ffrancon (CN399). Plate 4 provides a view east towards the site, within the trees, from another nearby spigot mortar site (PRN 29564). Pre-existing wooden telegraph poles can be seen to the right (east) and the revetment for the toll road of Ogwen Pass can be seen to the left (northeast).
- 10.5 The development site and the scheduled toll road (CN338) were both visible from the infantry position (PRN 29563; plate 5). An incomplete setting of eight anti-tank obstacles known as "dragon's teeth" (PRN 29562), lies between the spigot mortars and the site (plate 6). The site is visible from these anti-tank traps, again masked by the surrounding trees (plates 4 to 6). Both the toll road (CN338) and the pillbox (PRN 29556) were visible from the edge of the high ground to the north of the anti-tank traps (plate 7).
- 10.6 The closest spigot mortar mount to the site (PRN29561), located to the east, adjacent to the toll road (A5) and the Afon Idwal, also has restricted views to the site due to the tree cover (plate 8).

- 10.7 To the north of the proposed development area, one of the pillboxes (PRN 29556), located within the valley bottom, next to the Afon Ogwen, was under excavation at the time of the site visit by staff from the National Trust and Gwynedd Archaeological Trust (GAT). Photographs of the pill box from the toll road, (plate 9) and from the pill box to the site, (plate 10) show that views of the site are also restricted from this location. The scheduled revetment (CN338) upon which the toll road was built is clearly visible from this pill box, topped with preexisting wooden telegraph poles (plate 11).
- 10.8 A view of the site from the toll road (plate 12) shows the development area hidden among the trees, the pillbox in the valley floor and the Glyderau mountains beyond to the South.
- 10.9 A view looking northwards along the modern A5 trunk road show both it and the earlier toll road underneath and alongside it (plate 13) whilst views back toward the site (plates 14 to 16) from near Pentre Farm and two of the spigot mortar sites (PRN 29581 & 29582) show the site hidden within the trees under the shadow of the mountains.
- 10.10 An assessment of the site itself shows that it raised slightly above the levelled car park and is already occupied by a 6m tall wooden telegraph pole (plate 17). The car park itself provides a backdrop to the site towards the SE (plate 18). The floor of the site comprises angular slate fragments derived from quarry spoil, stabilised with grass and tree roots. Views from the site towards Llyn Ogwen in the east (plate 19) and NW up Nant Ffrancon (plate 20) are both restricted by tree cover.

11. Assessment of Significance

- 11.1 The proposed development area lies within the northern part of Snowdonia National Park. It is situated at the head of Nant Ffrancon with views along it to the NW. More precisely the site lies at the northern tip of the Idwal Youth Hostel car park, close to the outflow of Llyn Ogwen and the confluence of the rivers Afon Idwal and Afon Ogwen. The site also has commanding views to the east up Llyn Ogwen towards the pass at Cwm Llugwy as well as the Carneddau mountain range to the north and the Glyderau Mountains to the south. Despite its dramatic views the site is situated within a bustling and developed area adjacent to the A5 trunk Road from London to Holyhead comprising a car park, youth hostel and other local services. The site itself is small, comprising an area, within woodland, of only 6m squared and is perhaps intrinsically of low historical significance in itself.
- 11.2 The significance of the proposed development area is therefore assessed on two interconnected levels; the significance of the surviving heritage assets within the site footprint itself; and the significance of the setting within the wider landscape, particularly in relation to the setting of scheduled monuments and listed buildings potentially at risk from the development.

Evidential Value

11.3 There is very little in the way of recorded archaeological evidence for the proposed development site itself. Historic maps show that it lies at the northern tip of an artificially raised and levelled platform that probably comprises late 19th century spoil from a nearby slate hone stone quarry (PRN 20804). Several of the scheduled ancient monuments that

comprise Nant Ffrancon Anti-invasion defences (CN399) lie within very close proximity to the proposed development site. The closest being a spigot mortar emplacement less than 35m from the site. There is potential that some hitherto unrecorded element of this defensive line may lie buried within the footprint of the proposed development. The monument is of national importance for its potential to enhance our knowledge of World War II anti-invasion practices. The monument is well preserved and has a collective group value. It is an important relic of actions taken against the perceived threat of a German invasion from Ireland. It retains significant archaeological potential, with a strong probability of the presence of associated archaeological features and deposits (Cadw ancient monument schedule).

- 11.4 A second scheduled monument lies close to the development site; The Holyhead Road: the Ogwen Pass (CN338) which comprises a long stretch of revetment walling traversing the east side of the Nant Ffrancon valley that accommodates Thomas Telford's Holyhead Road (now the A5). At its closest point this monument only lies 60m north of the proposed development site and it is possible that sub surface evidential remains of the related engineering works may survive within the footprint of the site.
- 11.5 The evidential value of the development site itself for post medieval industrial and military archaeology that may form part of the setting for the Scheduled Monuments discussed above can be considered to be medium, however, overall the evidential value for previous archaeological activity is low. It should be noted that evidential value is different from archaeological potential, which currently remains unknown. The evidential value of the associated scheduled ancient monuments is high.

Historical value

- There are few known documents that relate directly to the proposed development site, other 11.6 than the usual 19th century maps and associated documents. The site lies in an area that was not titheable, possibly because it may have been crown land. There are extensive records in the National Archives and the Gwynedd Archives relating to a dispute over mineral rights between the Penrhyn and Crown estates. A search of documents held in the Gwynedd Archives (Caernaryonshire Record Office), Bangor University Archives and special collections, as well as the National Archives in Kew, indicate that there is a wealth of documents relating to the wider area and the Penhryn estate in particular dating back to the 13th century. These include deeds, estate, papers, household papers, tenancies and papers relating to the extraction of minerals. Furthermore, the site is set within the midst of a scheduled monument of high historical value (Nant Ffrancon anti-invasion defences) of National and international importance, in that it relates to a World War. There are further historical and literary associations in the wider landscape. For example, the neighbouring mountain of Tryfan, whose peak is less than 1.9km SE of the site, was used as a training site by Sir Edmund Hilary prior to his ascent of Everest.
- 11.7 Nevertheless, the historical value of the proposed development site footprint itself can be considered to be low. The historical value of the associated monuments and landscapes is high.

Aesthetic Value

- 11.8 The proposed development site is located within the Ogwen Valley Historic Landscape Character Area HLW (Gw) 10. The Historic Landscapes Register and the characterisation exercises fully acknowledge the dynamic and evolving nature of the landscape. They promote the view that protecting the legacy of the past in the landscape is not to be achieved by preventing change or fossilising the landscape but rather by informing the process of change, creating tomorrow's landscapes without necessarily sacrificing the best of yesterday's (Gwynedd Archaeological Trust, http://www.heneb.co.uk/hlc/hlc.html accessed 18/11/2019).
- 11.9 The Ogwen Valley, or Nant Ffrancon, has certainly been the witness to a dynamic process of historic change over many centuries. In fact, its dramatic landscape is largely the result of dynamic geomorphological change over many millenia in the form of the process of glacial erosion that has resulted in the distinctive flat valley floor, steep sides and hanging valleys. It is this natural process that ultimately led to the valley pass becoming important as a communications route through the mountains in the post medieval period. This, in turn, necessitated the defence of this arterial route during WWII. Glaciation also provided access to outcrops of slate for quarrying, a process that ultimately led to current shape of the development site itself. Furthermore, it is the direct lines of slight along these glaciated valleys that make the site important for the location of modern communications masts. The valley is already traversed by 20th century telegraph poles, one of which sits on the site itself and others atop the neighbouring scheduled revetment for the Ogwen Pass. The current development proposals should therefore be considered in the light of this long and continuing process of historical development.
- 11.10 The overall aesthetic value of this landscape area can be categorised as high. Nevertheless, there are some factors which have reduced the aesthetic value of the immediate environs of the site. These include the construction of the car park and the proximity of a major trunk route (the A5).

Communal Value

- 11.11 The proposed development site is located on open access land within the Snowdonia National Park. It is located within one of the sections of the National Park that is easiest to access by road, located next to a car park on the A5 trunk road from London to Holyhead. The site therefore has significant communal value as a location at which travellers can stop safely and appreciate both the natural and nationally important historic landscapes of the Ogwen Pass. The tree covered clump at the north end of the car park provides a natural backdrop through which the public can currently move to reveal dramatic views.
- 11.12 This means that the site features strongly as a current source of social interaction and is likely to retain a high communal value in the future.

12. Potential impacts

12.1 The proposed development is for the erection of a 15m high timber clad monopole supporting three antennas and two dish antennas together with ground based equipment cabinets, VSAT dish within a wooden clad enclosure and ancillary development on land adjacent to Ogwen Car Park. The site is also adjacent to a pre-existing 6m wooden telegraph pole. Set in a clump of 9m tall mature trees the current telegraph pole does not extend above the tree cover while the proposed mast will extend approximately 6m above the current canopy. The development will require groundworks associated with the infrastructure as well as for power supply ducts. This work will potentially have an impact on sub-surface archaeology, as well as the aesthetic setting of the adjacent scheduled monuments of the Nant Ffrancon Anti-invasion defences (CN399) and The Holyhead Road: the Ogwen Pass (CN338). There will also be a visual impact on the surrounding natural and historic landscape of Snowdonia National Park and the Ogwen Valley Historic Landscape Character Area.

Impact on evidential and historic value.

- The proposed development will involve groundworks for the laying of foundations for the mast and ancillary structures as well as excavation for the power supply duct. The latter will largely be excavated through the car park and Nant Ffrancon old road. The car park is constructed on the site of a spoil heap from a 19th century slate hone stone quarry (PRN 20804). This spoil heap became the backdrop for some elements of the WWII defences of Nant Ffrancon. The ground has been artificially levelled during the construction of the modern car park, so that the potential for sub-surface archaeological deposits associated with the WWII site may be reduced here. Nevertheless, some potential may remain, and this potential will be enhanced on the development site itself where ground levels appear to be unaltered.
- 12.3 The development therefore will clearly impact upon the current evidential value of the site focussed on its sub-surface archaeology. Development at this stage does however offer the positive opportunity for the site to be appropriately recorded to increase the recorded element of its evidential value before deterioration progresses to a point where the site is harder to understand. Archaeological mitigation in the form of an archaeological evaluation of the development footprint in advance of any groundworks taking place, or a watching brief during ground works would go some way towards mitigating against this impact and increasing recorded evidential value.

Impact on aesthetic value.

There is already an existing telegraph pole erected on the site, approximately 6m tall and constructed from wood, weathered grey, and in keeping with the colours of the slate dominated natural and historic landscape elements. The development proposals are for a 15m tall mast, timber clad, the uppermost part of which will extend 6m above the tops of the tree canopy. Furthermore, the associated infrastructure will occupy an area of approximately 6m x 6m on the ground, comprising a wooden clad enclosure for a VSAT dish as well as a power cabinet and a Blenheim cabinet. One of the existing trees will be trimmed to accommodate the site.

12.5 The mast and associated infrastructure will be located less than 35m from part of a scheduled ancient monument, potentially compromising its aesthetic value. However, the significant views associated with the scheduled monuments close to the site will be partially shielded by the clump of mature trees surrounding the development site. These trees will effectively mitigate against the visual impact of the ground-based infrastructure associated with the development on the setting of the scheduled monuments. However, the upper most 6m of the mast will protrude above the tree canopy and will be visible from the neighbouring monuments. This may also have a visual impact on the natural setting of the National Park as well as the historic character of the Ogwen Valley historic landscape character area. Nevertheless, it is expected that this impact will be small, reduced by the wooden cladding on the mast and the fact that there are already several telegraph poles standing in the immediate vicinity of the site and atop one of the scheduled monuments (Holyhead Road: Ogwen Pass).

Impact on communal value.

12.6 The communal value of the site is currently high. It forms part of the border around a busy car park which itself provides an important and safe stop off and access point for the appreciation of both the natural and historic landscapes in and around the Ogwen Pass. The current development proposals indicate that there are currently no plans to restrict access to the site once development has been completed, so the impact will be restricted to the effective removal of a 6m x 6m area which will house the ground-based infrastructure for the development. Access around these cabinets are proposed to continue as before.

Other risks/benefits.

12.7 The neighbouring scheduled pill box (PRN 29556) within Nant Ffrancon is currently being excavated by the National Trust and the Gwynedd Archaeological Trust. Any archaeological mitigation during groundworks associated with the proposed development would be able to benefit from knowledge gained during these associated excavations and equally feed into the results of those excavations. It will also provide the opportunity to explore part of the environs of the scheduled WWII defences without risk of damage to any of the scheduled remains. This will also inform the potential for other sub surface remains associated with the scheduled monument in the vicinity of the monument, thus enhancing the evidential and historical value of the site. The communal value of the site could also be enhanced by making the results of the excavations publicly accessible, perhaps through the placement of historical story boards in the car park.

13. Conclusions

13.1 This Heritage Impact Assessment has examined the impact of the proposed erection of a 15m high timber clad monopole supporting three antennas and two dish antennas together with ground-based equipment cabinets, VSAT dish within a wooden clad enclosure and ancillary development on land adjacent to Ogwen Car Park. It has also considered the impact of the development on designated heritage assets within the wider historic environment. The

- guidance offered within Managing Heritage Impact Assessment in Wales (Cadw 2017) has been used, which advocates examining the Evidential, Historical, Aesthetic and Communal values of the historic assets.
- 13.2 The site lies within Snowdonia National Park and the designated Ogwen Valley Historic Landscape Character Area HLW (Gw) 10. Cadw have identified two Scheduled Ancient Monuments within 50m of the site that may potentially be impacted by the development. These are the Nant Ffrancon Anti-invasion defences (CN399) and The Holyhead Road: the Ogwen Pass (CN338). Only the upper 6m of the mast will impact on the setting and aesthetic value of these heritage assets, the lower part and the ground-based infrastructure being shielded by surrounding mature trees, although groundworks may have an impact on evidential value associated with the heritage assets.
- 13.3 The Nant Ffrancon Anti-invasion defences (CN399) is a monument of national importance for its potential to enhance our knowledge of World War II anti-invasion practices. It is well preserved and has a collective group value and retains significant archaeological potential, with a strong probability of the presence of associated archaeological features and deposits (Cadw ancient monument schedule). The proposed development of the mast and associated structures will undoubtedly impact upon the evidential and historical value of the site itself, by removing archaeological potential. This however may be mitigated by an appropriate level of archaeological recording to add in a positive way to the existing evidential value. The site does not contain known archaeological features of sufficient significance to preclude development of the site. However, the possible presence of archaeological remains may require further archaeological assessment, such as an archaeological evaluation and/or watching brief during the groundworks phase of the development, in order to clarify and/or record the potential for buried archaeological evidence associated with 19th century quarrying and WWII defences.
- 13.4 The communal value of the site is high but will not be significantly impacted by the development, especially if access, with appropriate cautionary notices, to the woods and the views beyond remains open to the public.




Figure 1. Site location






Figure 2. Detailed Site Location Plan.




Figure 3. Proposed Development Plan




Figure 4. Non-designated Archaeological Sites held in the HER within a 1km search radius.






Figure 5. Registered Landscape Ogwen Valley - HLW (Gw) 10 - within applied search area.






Figure 6. Scheduled Ancient Monuments within applied search area.






Figure 7. Listed Buildings within applied search area.






Figure 8. Ordnance Survey County Series, Caernarvonshire, 1889 edition. Originally printed at 1.2500.






Figure 9. Ordnance Survey County Series, Caernarvonshire, 1900 edition. Originally printed at 1.2500.






Figure 10. Ordnance Survey County Series, Caernarvonshire, 1914 edition. Originally printed at 1.2500.







The route of the earlier turnpike has a substantial rock cutting, revetment and a fragmentary arch preserved beneath Telford's bridge. (Cadw, 2004) The turnpike emerges from under Telford's road revetment 730m from the head of the valley and survives as a generally well-preserved revetted terrace (Plate 5 and Plate 6).
