Pitched slate and tiled roof. Two storeys. Rectangular plan; original cottage (now shop) with parallel stable extension. Front elevation; cottage has central entrance with porch, two six-paned windows to each storey, and central blind window. Stone gable chimneys, rebuilt. Left side of block is extension to the house, and has tie plate where internal wall separates house from stable. Irregularly spaced windows, LC20 casements with glazing bars. C20 rubble stone buttress adjacent to right window. Gable end shows trace of earlier segmental-arched opening, now with LC20 casement windows to ground and first storeys. Back elevation much altered, for toilet facilities.
