

BACKGROUND

A recent report by John Manley (1990) highlighted the potential importance of a group of undated small enclosed settlements in Clwyd to our understanding of rural settlement in this region during the later prehistoric to early historic periods.

The report identified 60 probable and 10 possible enclosure sites selected from the Sites and Monuments Record represented by earthworks and/or as cropmarks of types which fall within a definition of 'an area defined by an enclosing perimeter, large enough to contain one or more buildings' and which although very diverse and almost wholly undated are of types which would generally be considered to be principally of later prehistoric to Romano-British and possibly early date. Few of the sites included in the report have been excavated and none are securely dated. Subsequent excavations at the Craig Fechan enclosure (PRN 101756), one of a number of similar, small, curvilinear earthwork enclosures in certain parts of the county (omitted from the 1990 report), has suggested that this site forms part of a more extensive late Bronze Age landscape (Manley 1991).

Manley's report includes valuable analyses various aspects of these sites, including the following: altitudinal range; area enclosed; shape (eg those with straight boundaries and those with curvilinear boundaries); topography (eg whether defensively sited or not); form (eg those surviving as earthworks, stoneworks, or cropmarks); ancillary features (eg huts, hut platforms, associated field systems); and condition.

Both research and conservation archaeology of the later prehistoric and Romano-British archaeology of Clwyd have inevitably focussed on the major impressive Iron Age hillforts dominating the major river valleys and the important Romano-British industrial sites along the north-east coastline. Manley's stresses that greater attention must now be devoted to these lesser settlements, of which fewer than 25% are protected as Scheduled Ancient Monuments.

PROJECT DESIGN

Proposals for undertaking a rapid assessment of small enclosures in Clwyd were approved and funded by Cadw in 1993/94 (Project CPAT 35).

The aims of the project were limited to a rapid assessment of the present condition and land-use of the sites in the published list of enclosure sites in Manley 1990 and a small number of sites identified more recently from fieldwork and aerial photography together with an assessment of the available recording of individual sites by measured ground surveys or by aerial photography.

The objectives of the project were to identify sites which may be under threat, to identify sites which might be worthy of scheduling, and to identify sites which require recording in greater detail as a basis for either scheduling and/or development control.

SUMMARY OF WORK UNDERTAKEN

Introduction

The fieldwork and archive elements of the project were undertaken in the latter part of the 1993/94, the preparation of this report being deferred until the subsequent financial year in order to enable a fuller assessment of the results and recommendations for further work to be prepared and partly because of the greater number of sites than anticipated.

The approximate timing of various elements of the project were as follows: 5 days research (SMR interrogation, examination of APs and OS map base); 30 days fieldwork; 15 days post-survey (archive preparation, data entry for SMR enhancement); 15 days report preparation.

Sites included in the Survey

A total of 113 sites have been included in the survey, of which the great majority were visited in the field. The study included the 60 probable and 10 possible sites listed by Manley (with the exception of Manley, fig. 8, no 2477, of which no further record has been traced), together with other sites which came to light from an interrogation of the SMR and from a search of CPAT and CUCAP aerial photograph collections. A number of the latter were only identified at a late stage in the project and were therefore not visited in the field.

Documentation and Fieldwork

The existing documentary, cartographic and AP sources for each of the sites were examined and assessed. The majority of the sites were visited in the field, allowing a rapid assessment to be made of the current land-use, state of preservation, and the adequacy of the existing documentary and cartographic sources.

Summary of types of sites represented

As noted by Manley, the sites form a very diverse group. No further attempt at analysis has been made, but for the sake of illustration the following 'types' can be noted: stone banked enclosures with no encircling ditch (eg PRN 100789); stone banked enclosures with external hut sites (eg PRN 100746); multivallate earthwork enclosures resembling small hillforts (eg PRN 100722); curvilinear cropmark enclosures (eg PRN 101817); rectangular earthwork enclosures (eg PRN 101810); rectangular cropmark enclosures (eg PRN 102653)

Summary of Current Land-use

The great majority of sites are in pasture, smaller numbers being under forestry or in woodland, in forest clearings, on moorland, in arable, or miscellaneous uses including recreational land (eg golf course, caravan park).

It is likely that many of the sites currently under pasture are ploughed periodically for pasture improvement. In one instance (PRN 101728) land-use has changed from arable to pasture between Manley's 1983/84 field survey, and in two instances (PRNs 101773, 103017) sites under pasture in 1983/84 were being ploughed in 1993/94.

Several sites are currently being damaged by farm vehicles and/or erosion caused by livestock (eg PRNs 101757, 101807). Two earthwork sites are being affected by ploughing (PRNs 101773, 103017).

Some of the sites on open moorland (eg PRNs 100724, 101229) were overgrown with heather and/or bracken when visited, and could not be clearly identified.

A number of the sites which are now in forestry (eg PRNs 100674) and those in forestry clearings (eg PRN 100734, 100735) are densely overgrown and difficult to identify.

Relatively recent damage appears to have been caused in one instance by a pipeline (PRN 100509), in one instance (PRN 100351) by levelling to create a caravan park, and in one instance (PRN 100256) by landscaping for a golf course.

SUMMARY OF RECOMMENDATIONS

The following recommendations are to some extent interrelated and are made strictly from the perspective of site conservation rather than research. See a summary of recommendations in Appendix 2 which follows.

The following procedures are suggested, firstly to provide further information where this is lacking (aerial reconnaissance, further site visits), secondly to provide metrically accurate plans of individual sites where these are lacking (ground survey, AP rectification), and thirdly to make recommendations for scheduling and to promote the preservation of sites as part of the planning process and by other means, on the basis of the extent and character of sites thus defined.

A metrically accurate plan, whether derived from ground survey or from AP rectification is considered to be a vital prerequisite for site preservation, whether for scheduling, for protection as part of the planning process, or for less formal liaison with landowners.

Some of the plans reproduced in Manley's report are metrically accurate and derived from unpublished or unpublished OS surveys. It should be noted, however, that a high proportion of the site plans in his report were sketch plans 'measured by pacing' or from sketch plotting of aerial photographs, and are divorced from modern boundaries mapped by the OS.

Site Visits

Further rapid visits are recommended in a number of instances either because identification proved difficult in a first visit to a site or because a site has been discovered since the fieldwork element of the project was undertaken.

Aerial Reconnaissance

Further aerial reconnaissance is recommended in a number of instances, where for example the existing AP coverage of cropmark sites is insufficient for the production of metrically accurate plans, or in instances where the only AP records are in private collections, or in some cases where it is felt that further aerial reconnaissance might provide important ancillary detail.

Ground Survey

Ground survey is recommended where there is no metrically accurate ground plan of an earthwork site (eg no OS survey), especially in instances where preservation is reasonably good and where a recommendation for scheduling is anticipated.

AP Plotting

AP plotting is recommended where there is no metrically accurate ground plan of a cropmark site, especially in instances where preservation appears to be reasonably good and where a recommendation for scheduling is anticipated.

Scheduling Enhancement

Sites already scheduled are given in Appendix 1. Provisional recommendations for scheduling of about 30 sites are shown in Table 2. These provisional recommendations are made on the basis of a number of criteria, including the following: well-preserved earthwork sites; well-defined cropmark sites; types of sites not already scheduled; unusual sites; groups of enclosures sites; enclosure sites forming part of a more extensive complex of sites; sites adjacent to scheduled monuments; enclosure sites in areas where none are already scheduled.

Further work will be needed to review these criteria and to establish a definitive list of recommendations for scheduling.

Further work will also be needed to establish ownership in many instances and to prepare other information for drafting AM7s. Illustrations of selected examples of sites which are provisionally recommended for scheduling are shown on pages 11-13.

It is to be anticipated that other conservation measures, as part of the planning process or by personal contact with landowners, will also be enhanced by further work.






Nant Tan y Foel Platform (PRN 100700), recommended for scheduling (OS 1:2500)




Bron Fadog Enclosure (PRN 102450), recommended for scheduling (OS 1:2500)




